President's Report by Rene Rodriguez

I am pleased to report that things are looking much better this year for retiree health benefits than they have since we began contesting the changes the District illegally and unilaterally made to our health benefits in July 2005.

A Very Important New Development for You

If you have been visiting our website (www.vcccdra.org), you already know that effective January 1, 2008, the out-of-pocketmaximum (OOPM) for mail-order prescriptions will be limited to \$500 per individual, and \$1,000 per family each calendar year. Prescription costs have been one of our major concerns, and this new provision will save thousands of dollars beginning this year for retirees who have been spending more than \$500 per year on prescriptions. Therefore it is imperative that you enroll in this program as soon as possible, particularly if there is a chance that a member of your family will spend more than \$500 in prescription drugs this year. Payoff from Negotiations by the Association

This very important change to our health benefits has come about due to the negotiation efforts of retirees with the District. The last (third) proposal that the Retirees' Association made to the District contained a similar OOPM for prescription drugs. Not long after we made this proposal, the District and the bargaining units agreed to accept this new change to the District health benefit plans and becoming effective in January 2008.

However, as important as this new provision is to active employees and retirees, it will remain in effect only as long as the District and the bargaining units agree to keep it as part of their future contractual agreements.

This is one reason why the Retirees' Association has sued the District. Retirees should not have to depend on the future actions of the District with the bargaining units, and **by law**, bargaining units cannot bargain on behalf of retirees, and the Dis-

trict cannot unilaterally abrogate contracts/promises that it made to its retirees when they were active employees.

Thanks to the moral and financial support of individual retirees like yourself, the leadership of the Retirees' Association, especially the Benefits Committee, the Political Committee, and your Executive Board, has been able to maintain a strong, continuing effort towards resolving the health benefits issue with the District. The effort began more than a year ago with an attempt to negotiate a fair settlement. With little progress to show for all our efforts after months of negotiations, the Retirees' Association, filed a lawsuit against the District on August 31, 2007.

Progress with the Lawsuit

Since the filing of the lawsuit in August, the lawyers for the District requested a hearing in November 2007 in an attempt to invalidate our lawsuit and claim we are not entitled to attorney's fees and compensation for other costs. The judge overruled the demurrer and denied the District's motion to strike, thus leaving our claim against the District intact.

The next step in the process will be when our attorney, Tom Sharpe, asks that our lawsuit be certified as a class action suit. Also, depositions of selected retirees should begin soon to shed further light as to the promises that were made to retirees by the District regarding health benefits when they were active employees.

Bylaws Amendments

By this notice, at least 30 days before the annual general meeting, the Executive Board recommends to the membership present at the annual meeting on March 12 that the following articles in the bylaws be amended as shown below. The articles are shown as currently written with *proposed new language* presented in *bold* and *proposed deleted language shown in powder*.

- ARTICLE V, Section 4. Voting for officers shall be by voice, or a showing of hands, by members in attendance at the annual general meeting, unless a secret ballot is called for and approved by a majority of those present. However, members may vote by mail using an official ballot distributed by the Association. Members voting by mail must follow the instructions which will accompany the mail-in ballot. Secret ballots will be counted by the nominating committee.
- ARTICLE V, Section 2. The annual election of officers will be held at a general meeting held in the spring of each year on the third Wednesday of March, or the nearest Wednesday to this date depending on availability of accommodations.
- ARTICLE V, Section 1. The Executive Board shall appoint a Nominating Committee which will present its recommendations at a its annual general meeting. each year. Nominations may be made by mail to the Chairperson of the Nominating Committee any time prior to the annual general meeting cutoff date established by the Chairperson, or on the floor on the day of the annual general meeting.

The Executive Board also recommends the following change to the bylaws in Article VIII which will classify the Benefits Committee, the Political Committee and the newly formed Membership Committee as "standing committees."

ARTICLE VIII – STANDING COMMITTEES The President shall appoint all committee chairpersons as the need for a committee arises. The Standing Committees for the association currently are the Benefits Committee, the Membership Committee and the Political Committee.

Nominations and Election of Officers

All officers will have completed their terms on June 30, 2008, and new officers will need to be elected on March 12 to begin their terms on July 1, 2008. - 3. I am pleased to announce that Don Medley has accepted the chairmanship of the newly created Membership Committee. This will give Don, founder of the Retirees' Association, official status for all the work he continues to perform for the association

George McNeely's \$25,000 Matching Pledge

Other Positive Developments

Benefits Committee Report by Gary Johnson

Since the District unilaterally changed the retiree health benefit plan in June 2005, the VCCCD Retirees Association has continually made a strong case to the Board and District that increased prescription co-pays are the most objectionable part of the plan change and place the most difficult financial stress on retirees.

We believe the District took a cue from our last negotiations counter offer in agreeing with both SEIU and AFT to incorporate a \$500 out-of-pocket maximum (OOPM) enhancement in the mail order prescription plan associated with Blue Cross coverage.

Obviously this is a very important development, especially for the more than 340 individuals (45% of retirees and dependents) who have been exceeding \$500 in annual prescription expenses. This \$500 maximum limit to what retirees will have to pay out-of-pocket for mail-in prescriptions, while welcome, will last only as long as the District and bargaining units agree to keep it as part of their future negotiated agreements. One reason the Retirees Association sued the District is that the District has refused to agree to long-term limitations on retiree out-ofpocket health care costs. Retirees should not have to depend on the future actions of the District or settlements with the bargaining units, and by law, bargaining units cannot bargain on behalf of retirees. Furthermore, the District cannot unilaterally abrogate contracts/promises that it made to its retirees when they were active employ-

We urge retirees and dependents to fill prescriptions by mail, especially for those medications expected to be taken for three months or more. A large percentage of retirees are not ordering by mail and this new \$500 out-of-pocket maximum (OOPM) will be decidedly to your advantage. Currently, 205 of you are spending between \$500 and \$1000 on prescriptions; 123 are spending \$1000 to \$2000; and 15 are spending between \$2000 and \$3500. The new limit can save retirees collectively more than \$350,000. Whether or not you are spending over \$500 annually for prescriptions, ordering prescriptions by mail provides

you three months supply for the price of two, and over the course of a year that means four months of your prescriptions are free. Please request generic medications when available.

As retirees it is to our advantage to do everything we can to help keep District benefits costs contained.

District Benefits Committee

After a two-year exclusion and repeated retiree requests, the District has invited retiree representation on the Classified/Manager Benefits Committee and we expect soon to be added to the Faculty Benefits Committee. This is another welcome change and allows us to be part of the District health benefits decision and deliberation process.
