## Benefits Experts Provide Answers, Raise More Questions

Benefits experts from Anthem Blue Cross and Keenan & Associates captivated the attention of over 75 retirees and guests at the VCCCD Retirees Association annual meeting on April 1, 2015 at Moorpark College, but their presentation and Q&A session seemed to raise as many questions as it answered.

Sharen Stanek Lowe (Keenan & Associates) and Steve Glore (Anthem Blue Cross) gave a PowerPoint presentation on the topic, "How to Get the Most from Your Medical Benefits." They offered a number of out-of-pocket cost containment suggestions, including:

- 1. When a situation is not a true emergency, seek immediate medical care through health clinics located in pharmacies and urgent care centers, or consult with a physician directly through the website *livehealthonline.com*.
- 2. Use the <u>www.anthem.com/ca</u> website to identify discounts on such items as eyewear, hearing aids, teeth whitening, medicine, and fitness club memberships.

- 3. Use the <a href="www.anthem.com/ca">www.anthem.com/ca</a>
  website to compare hospitals
  and average charges for
  common procedures such as
  knee and hip replacements.
- 4. Choose generic drugs, over the counter drugs, or Tier 1 (lowest copay) drugs, and use the Express Scripts mail order system.

Following the 20-minute presentation, Sharen and Steve spent the next hour addressing many attendees' questions, including those regarding spousal coverage, unresolved claims problems, and the interaction of Medicare with Anthem Blue Cross. Not all questions could be answered to everyone's satisfaction, but Steve did offer his business card and contact information to those who felt their claims had not been processed correctly.

VCCCDRA President René Rodriguez thanked Sharen and Steve for their informative presentation and Q&A session, and the attendees gave them a round of applause.

René also introduced new Moorpark College president Dr.


Luis Sanchez. Dr. Sanchez welcomed attendees and provided them with information on his background, education, and previous legal and community college experience. He also provided an update on recent Moorpark College accomplishments.

Attendees unanimously approved the minutes of the March 27, 2014 annual meeting as prepared by Marie Soo Hoo, Association Secretary. They also reviewed the treasurer's report as prepared by Patricia Gage, Association Treasurer.

Gary Morgan presented a report from the Nominating Committee: Since there were no candidates for President and Vice President of VCCCDRA, nominations would be taken from the floor.

Following extensive discussion of possible candidates by attendees, René Rodriguez was nominated from the floor, then unanimously re-elected to serve as President of the Association for a two year term.

Betty Hough was then nominated from the floor to serve as Vice President of the Association.



René then presented two proposed <u>amendments</u> to the *Bylaws* of the *VCCCD Retirees Association* for consideration:

The amendment to Article V (Elections) Section 7 would allow for re-election of a former president again after two years out of office unless there is no candidate for president at the annual meeting.

The amendment to Article V (Elections) Section 9 would allow

the appointment of an associate member to any vacant officer position due to a resignation during a term of office.

In addition, René also presented two <u>new</u> proposed sections to the *Bylaws*:

New Article III (Members) Section 5 would allow current VCCCD employees who are planning their retirement to become associate members of the VCCCDRA.

New Article V (Elections) Section 10 would allow the Association to function as a body if neither a president nor a vice president is elected at the annual meeting.

Following a brief discussion, the attendees voted to approve all four changes to the *Bylaws*.

As he concluded the annual meeting, René again thanked keynote speakers Sharen Stanek-Lowe and Steve Glore for their informative presentation and to everyone in the audience for attending the meeting.

# **Gary Morgan: Respected Colleague and Friend**

The VCCCDRA lost a respected colleague and good friend with the sudden passing of Gary Morgan on April 30, 2015 after a brief illness. Gary was a journalist, writer, and teacher who devoted himself to his family, friends, profession, and students.

Gary was born in San Diego but pursued his education out of state, earning a B.A. in English at New Mexico Highlands University and an M.A. in English at Colorado State University. After completing his M.A., Gary was hired at Colorado State University as their Sports Information Director—one of the youngest in the country.

After a number of years at Colorado State, Gary accepted a position teaching journalism at Metropolitan State University in Denver, Colorado. He also continued his studies at the University of Northern Colorado, earning a doctorate in Journalism. His dissertation topic focused on International Mass Communications, a field that was just developing at that time.

When a teaching position opened at Oxnard College in 1984, Gary was hired to teach journalism, including courses in mass communications. He was also the faculty advisor for the student newspaper, *The Campus Observer*. In addition, he served as president of the Academic Senate, chair of the Staff Development Committee, and was committed to the success and growth of Oxnard College and its students.

During his lifetime, Gary wrote for a number of newspapers, both in California and in Colorado, and published six books. One was Sugar Tramp, the history of a train line that hauled sugar beets in Colorado. Another book was Yes, You Can, a book he coauthored and edited with Helynn Hoffa, that showed people with disabilities how to improve their lives. Among other works, he also published a poetry collection titled There Was So Much Laughter.

Gary very much enjoyed fishing, traveling, and playing bridge with his spouse, Dagmar Ragnow Morgan, who survives him. Gary also served as president of a local bridge club. In addition, he loved reading, getting together with friends, and many other activities. He even took a Cordon Bleu class and was an excellent chef.

Gary was active in the VCCCD Retirees' Association for several years following his

retirement from Oxnard College in 2004. He served as vice president, newsletter editor, and chair of the Political Committee. His absence is deeply felt by all of us.
